### **Summary**

The FleetSafe Workshops are an innovative and effective way of delivering tools to business to help them develop and implement safer vehicle and driving policies. This unique and exciting concept is the only workshop of its kind being delivered in Australia or overseas.

Road crashes are the major cause of workplace fatalities (49%) and road trauma is a significant cost to the community. Vehicles are now defined as 'workplaces' and employers now recognise that their duty of care must encompass vehicle safety and driving behaviour.

The FleetSafe Workshops advance State and local government road safety strategies, with vehicle safety identified as a key objective. Overseas research shows that "if everyone drove the safest vehicle in its class, fatalities could be reduced by 30-40%"; these forums provide both the information and the motivation to progress this key objective.

The FleetSafe Workshops are sustainable. They have had strong support from major road safety partners since their inception and have attracted ongoing sponsorship. Partnerships with our partners in road safety: Allianz Insurance, Bosch ESP, Streets Ahead Pty Ltd, Subaru Interactive, TAC, VicPolice, VicRoads and local government, have helped deliver the first four workshops and are integral to the success of the workshops.

Business participation, referral and networking have helped grow the program; this has gathered further momentum with the support of the Victorian Workcover Authority, who have thrown their support behind the program by publicising the workshops through their website and industry email network.

The FleetSafe Workshops have SMART objectives, are multi-actioned and outcomes are easily evaluated. To date, 100% of businesses that participated in the first three workshops have implemented workplace procedures, 80% have introduced a fleet purchase policy, while 60% have developed a safer driving policy. Registrants have been drawn from major businesses: metro and country Victoria, as well as interstate. 95 businesses have attended the four workshops and a fifth is almost fully pre-booked, demonstrating the strong business demand.

RoadSafe Inner South East Inc. (RISE) developed the workshops, which have the support of the other four RoadSafe groups in MSE Region. Regional RoadSafe groups and local government have expressed interest in hosting workshops, three mini regional workshops have been run, and FleetSafe has been promoted at a national OH&S forum.

## The Extent of the Issue

### *Statistical Data*

- Road crashes are the major cause of workplace fatalities, injury and absence from work<sup>1,2</sup> (estimates vary from 23% work-related deaths for business travel and 26% for commuting, i.e. 49%<sup>3</sup>, to 43% of work-related fatalities<sup>2</sup>)
- Work-related road crashes cost businesses more than \$1 billion per annum<sup>2</sup>
- Work-related road crashes account for a significant proportion of the road toll (25% of road fatalities<sup>2</sup>)
- The National Safety Council of Australia suggests the average cost of a fleet crash is \$18 500.00.
- If every fleet driver drove at the speed limit, the general public would have no choice but to drive at the speed limit also.

### *Research*

- Research shows that fleet purchases account for the majority of new car purchases (60%<sup>3</sup>) and that organisations on-sell their fleets every three years on average
- Metro Inner South East (MSE) has thousands of businesses: large and small, local and national, commercial and non-profit, with many nationals headquartered in MSE Region, and 16 local government organisations
- Research into fleet crashes suggests that businesses and employees often engage in unsafe practises: drivers drive longer distances for business, adhere to tight schedules, are often fatigued and are less concerned about wear and tear on company vehicles<sup>1,2,3</sup>
- Company car drivers are also more likely to speed, tailgate, show aggression, lose concentration and use their mobile phone while driving<sup>2</sup>
- Even after adjusting for distance travelled, company car drivers have roughly 50 percent more crashes than ordinary drivers
- Research has found that incentives (non-monetary) work better than monetary rewards in changing workplace culture<sup>2</sup>
- Work-related crashes impact not just directly on a business, but indirectly, through personal and social trauma associated with those connected to the business and the incident<sup>3</sup>.

## Specific Program Objectives

1. To influence businesses (used interchangeably with *organisations*) to prioritise safer driving and fleet safety
2. To assist businesses to develop and implement a Road Safety Policy and procedures
3. To influence workplace culture to make employee safety and safer driving normative and high priority
4. To influence the demand for vehicle safety features in fleet vehicles and to make vehicle safety features standard items, not add-on
5. To engage partners in road safety to support the delivery of fleet safety policy workshops, to reach the widest possible audience

6. To influence the insurance industry to support businesses that implement Road Safety Policies and procedures
7. To influence government to legislate for inclusion of vehicle safety features in all new vehicles, as in the US
8. Ultimately, to reduce the road toll and human impact of work-related crashes.

### **Objectives**

The main aim of the FleetSafe Workshops is to provide businesses and organisations with the knowledge and tools to advocate for a safer driving culture in the workplace and to develop and implement:

- ❖ **A Safer Driving Policy**
- ❖ **A Fleet Purchase Policy** that specifies the purchase of the safest vehicle in its class (and lobbies manufacturers to include safety features as standard, not extra) and
- ❖ **Workplace Procedures** for induction of staff, training and monitoring of driving practices.

### **SMART Objectives**

**Simple:** draft policies, procedures and resources are all provided

**Measurable:** the success of the workshops may be measured by the number of businesses implementing policies within the workplace

**Achievable:** with sponsorship, it is possible to grow the program to meet demand

**Realistic:** businesses can easily adapt the policies provided to suit their business needs

**Timely:**

- The draft State arrive alive! Strategy 2007-12 identifies vehicle safety as a priority
- OH&S legislation now classifies vehicles as 'workplaces'
- Employer's duty of care extends to vehicle usage.

### Details of the Program Elements

The FleetSafe Workshops are a multi-action program that focuses on providing businesses with the knowledge and tools to develop, implement and advocate for:

- ❖ **A Safer Driving Policy** in the workplace
- ❖ **A Fleet Purchase Policy** that specifies the purchase of the safest vehicle in its class
- ❖ **Workplace Procedures** that induct staff, train them and monitor safe driving practices in the workplace, and
- ❖ **Manufacturers** to include safety features as standard, not extras.

#### *Education Activities*

The workshops educate businesses on:

- The Safe Systems approach to road safety
- Development and implementation of a Road Safety Policy and procedures
- Safer vehicle features (TAC Safe Car, ESP, airbags etc.)
- Purchase and maintenance of safe fleets (ANCAP safety ratings)
- Workplace approaches to driver assessment, induction, monitoring, education and safety.

#### *Enforcement Activities*

Work with VicPolice to identify at-risk businesses and to advocate for them to attend a FleetSafe Workshop to educate them on developing a safer driving policy, fleet safety policy and procedures.

#### *Engineering Activities*

Advocate for industry to support the development of vehicle safety features and their inclusion as standard features in new vehicles. Manufacturers such as Bosch ESP, work with the FleetSafe Workshops to advocate for vehicle safety features to be included as standard in vehicles. At present, many imported vehicles with fitted safety features are sold in Australia with these features removed! Since the first workshop, the proportion of vehicles sold with ESP fitted has increased significantly, from 12% in 2005 to 17% in 2006 (Mark Jackman, ESP Bosch, pers. comm.).

#### *Policy / Advocacy Activities*

- Assist businesses to enshrine fleet safety in Safer Driving Policy, Fleet Purchase Policy and procedures
- Influence workplace culture to promote driver safety as normative and high priority
- Advocate for insurance partnerships to provide a financial incentive for businesses to prioritise driver and fleet safety
- Advocate for manufacturers to make vehicle safety features standard in cars, not extras
- Advocate for government to legislate for inclusion of vehicle safety features in all new vehicles, as in the US

The FleetSafe Workshops have received publicity through the local press, at State conferences, in country regions and at a national OH&S conference.

Mayors and councillors have attended workshops and interest from local government has been high.

Business advocates include our sponsors: Allianz, Bosch, Streets Ahead, Subaru and VicRoads. Other advocates include TAC, VicPolice, WorkCare, RoadSafe groups and emergency services.

There has also been discussion with the VFF and AWU, in partnership with the VCFL, to develop a suitable approach to rural driver safety, policy and practices (Appendix VIII). The VCFL have come in as a partner to assist with development and delivery of Farmsafe-RoadSafe workshops. The VCFL attended the second workshop.

### **Program Sustainability through Strong Community Partnerships**

The program is simple to implement and to update, so it is sustainable consistent with the availability of our road safety partners, who donate their time to speak, and the cost of brochures and workshop folders for the tote bags.

Our **business partners in road safety** are happy to assist, as it helps achieve their own businesses goals. However, they have limited time to donate to the workshops, as their time is a cost to their business. To date, they have supported two workshops per year, but have indicated they could support up to four per annum. Other speakers from related industries could replace them if necessary.

New resources can be integrated easily into the tote bags, which are sponsored by **Allianz Insurance**. New policies can be readily included in the workshop folders. Workshop notes can be readily updated.

Costs of the **Safer Driving Kit** are relatively expensive and have been the main cost to date. However, **VicRoads/TAC** has produced a revised kit, on DVD, which will be available to businesses at no cost.

Catering has been sponsored by the **host venue, local government and Subaru @ Docklands**. There are many councils willing to host a workshop and Subaru are happy to sponsor further workshops. The venues are provided free.

There are thousands of businesses in MSE Region alone and it was always intended that this program be community-driven. **Community members of RoadSafe** have donated their time for free, along with **VicPolice**, to help staff the workshops on the day.

**VicRoads, TAC and other State and Federal Government departments** have supplied brochures for free. VicRoads staff from MSE help plan, organise and run the workshops. Paid facilitation is unnecessary.

Monitoring the program is not onerous. Much of the data is collected at the time of registration.

### **Budget and Funding for the Program**

#### ***Costs for Initial Development, Trial, Resourcing and Launching of the Program***

- RoadSafe Inner South East (RISE) budgeted to run the first two workshops, providing FREE Safer Driving Policy kits (worth \$200.00) to each participating business, paying for a professional facilitator to run them, and paying for printing of materials. Other RoadSafe groups in MSE Region assisted with the costs of the third and fourth workshops.
- Local government and one of our partners have provided the venue and catering.
- Road safety business partners provided their expertise or resources for free.
- VicRoads provided funding for the Road Safety Coordinator, who helped plan and deliver the workshops, and VicRoads co-sponsored the workshops through RISE.

- The main cost of the two earlier workshops was the paid facilitator.
- The third workshop dispensed with the paid facilitator, with the RISE Road Safety Coordinator MC-ing and the Team Leader Road Safety Behaviour and other coordinators hosting the workshop segment. This worked well and was continued in the fourth workshop, saving around \$2000.00.

### ***Costs for Current Development of the Program***

- ❖ FleetSafe Banner design and production: \$ 761.60

### ***Future Costs***

- ❖ Marketing of the workshops through WorkSafe and our partners: \$ -

### ***Compliance***

- ❖ FleetSafe complies with State-wide strategies and policies, local government strategies and policies, VicRoads strategies and policies, and local RoadSafe strategies and programs.
- ❖ FleetSafe promotes the independent ANCAP ratings and recommendations for vehicle safety.
- ❖ FleetSafe picks up on local crash stats and known research and can be readily adapted to suit any business of any size, profit or non-profit, urban or rural.

## **Evaluation**

### ***Evaluation to Date***

Four metropolitan FleetSafe Workshops have been run to date, plus three regional mini-workshops. A total of 95 businesses have attended, many sending multiple delegates from Fleet Management and OH&S / Risk Management areas. Attendance has built exponentially (refer Table 2).

The workshops have been progressively evaluated and modified to achieve the present format (refer Appendixes I, V, VI and VII). The third workshop tightened its focus on driver safety and safe vehicles. Businesses workshopped an action plan and began developing a Safe Driving Policy and procedures to implement back in the workplace. Consequently, delegates at the third and fourth workshops felt that nothing needed to be changed. Feedback indicates that both delegates and presenters' needs are satisfied by the present format, though some would like a longer workshop.

The workshops' success is demonstrated by the fact that delegates had to be turned away two weeks prior to the fourth one, as it was fully subscribed, resulting in pre-bookings of 72% for a fifth workshop!

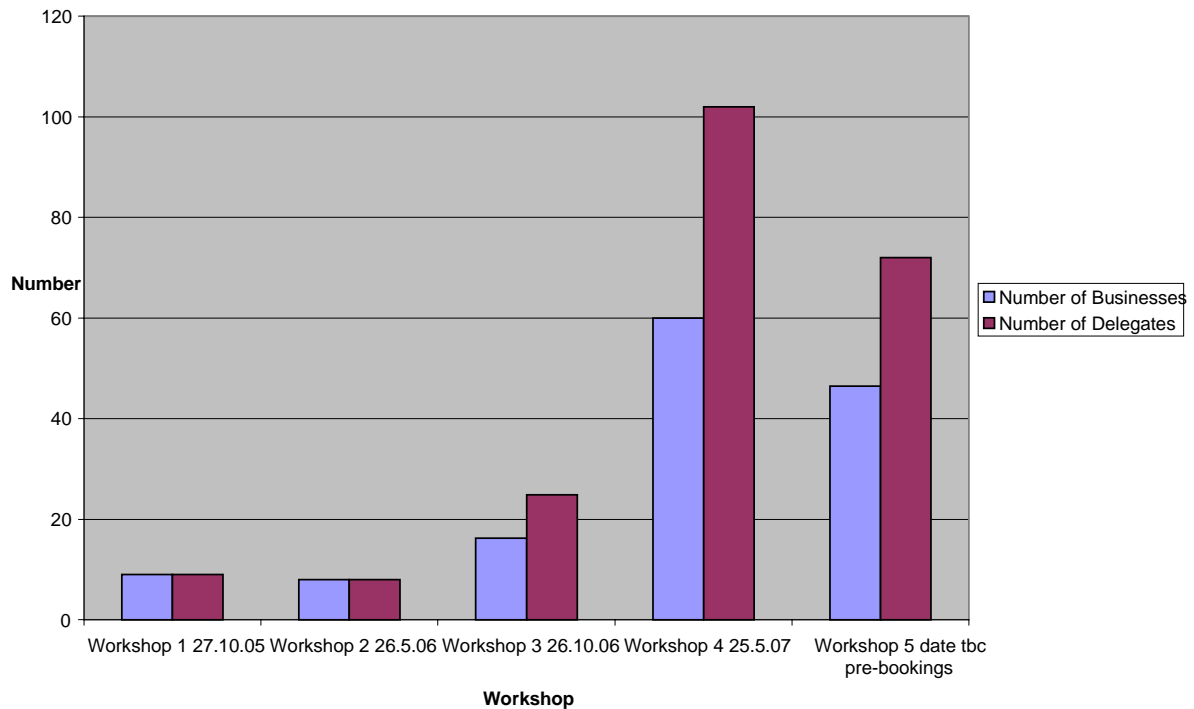

### ***The Influence of Company Size***

The workshops have attracted a mix of businesses and fleet configurations:

- from 5 to 5000 vehicles
- predominantly sedans or mixed (sedans, 4WD drives, utilities, vans, trucks, tractors, other plant)
- small, medium and large businesses
- local, national and international organisations
- profit and not-for-profit organisations
- local and State government organisations
- utility companies.

All Local Government organisations in the MSE Region, except one, have now attended the FleetSafe Workshops. The outstanding council is booked for the fifth workshop.

Surprisingly, many of the larger national and multi-national companies lack any written policy. These large companies have been quick to endorse the workshops and have sent multiple staff along.

The policies and procedural ideas provided are able to be adapted at the business level to suit the particular business environment. These may be updated as required.

The smaller the company, the quicker they have developed and implemented policy; two companies with small fleets (5-10 vehicles) implemented policies within one month. Larger companies have more steps, more layers of management and more levels of compliance to meet.

### ***Attendance of Both Fleet and OH&S/Risk Managers***

Evaluation has proven that both Fleet and OH&S/Risk Managers need to attend the workshops, as they are jointly involved in the development and implementation of policy. Also, research has shown that by making the commitment to send dual delegates, management have already endorsed the process and allocated staff resources to follow up.

OH&S staff are the drivers of Safer Driving Policy development and implementation, because they are responsible for compliance and risk management and for staff induction, training and monitoring. They work in tandem with Fleet Managers to ensure compliance with policies. Fleet Managers are more concerned with the development of Fleet Purchase Policies for the purchase of safer vehicles.

The first two workshops attracted single business delegates, mainly Fleet Managers, with few OH&S staff, and were slower to adopt policies. If the staff member left the company, policy development did not happen. The third and fourth workshops attracted an increasing number of dual (or even triple) delegates from both segments. Feedback from the third workshop indicates that policy development and implementation has been greater. It is too early to assess the results of the fourth workshop.

### *Impediments to Implementation*

Delegates attending the first two workshops reported impediments to change including: staff movement, business systems upgrades, business takeovers, lack of budget, lack of staff resources and management endorsement.

By emphasising the need to send representatives from both Fleet and OH&S/Risk areas, most of these impediments are mitigated: staff are committed, there is more likely to be management and budget support, and it is unlikely that both delegates will leave. Other changes are beyond our control.

### *Changes in the Future*

Demand for the workshops has grown exponentially. Growth in the number of workshops to meet demand is dependant on sourcing further corporate sponsorship.

The original *Safer Driving Kit* supplied to all businesses attending, at a cost per unit of \$200.00, is untenable as a long-term resource. It is currently being updated to a cheaper DVD format, which will represent significant savings in resourcing the workshops.

Endeavour to:

- Monitor road safety statistics for participating businesses, if available
- Monitor any indicators detected by our insurance partner
- Monitor policy writing and implementation and establish a policy 'library'
- Collate incentives put in place by businesses to influence management and employees
- Document changes in workplace culture reported by participating businesses
- Identify impediments to change and policy uptake and determine methods to overcome them
- Monitor budget for running workshops.

## **Innovation**

The program is a world **first**. It is innovative, simple, intuitive and easily implemented.

FleetSafe is **not restricted to any one type of business**. It can be implemented in an urban or rural environment and applies to all levels of business, not-for-profit organisations and governments operating fleets.

The FleetSafe Workshops are relatively **low-cost**, the program is affordable and can therefore be rolled out on a State-wide basis.

The FleetSafe Workshops are well-supported by our road safety partners, making them **authentic and practical** for businesses attending.

## **Acknowledgements**

The Fleet Safety Policy workshops are very much a whole-of-community effort, with strong resident, business, local government, State government, organisational and sponsor support.

Pierre Castelino was instrumental in planning and promoting the first workshop. A paid facilitator helped plan the first workshop and was engaged to facilitate the first two workshops.

Key members of the RISE Executive helped plan, organise and deliver the earlier workshops: Hans Harms (VicPolice), David O'Sullivan (ex-City of Kingston, now VicRoads), Joe Cusmano (ex-Bayside City Council) and Rosa Beveridge (community member) were instrumental; while Road Safety Behaviour Team colleagues have helped deliver the latter two workshops: Colin Lill, Heather Bishop, Tarmi Wright and Justin Grossbard.
